"The coordinator, Dr. Irfan Ahmed MS, presented the proposal. The Task Force observed that the proposal was well drafted. The existing infrastructure, student intake, and pass percentage were satisfactory. Technical portion was also satisfactory. The Task Force recommended clubbing of some departments for support.

Decision: The Task Force recommended financial support for three departments: (i) Computer Science and Mathematics (clubbed as one); (ii) Microbiology and Nutrition & Dietetics (clubbed as one); and (iii) Chemistry."

Provide quotation for equipment costing more than Rs. 1.00 lakh (including all taxes etc), only one equipment is allowed per department costing more than Rs. 3. 1.00 lakh within ceiling of Rs. 3.00 lakh (including all taxes etc).

As per the guidelines/Terms & conditions of Star College Program equipments like Laptop, Air conditioner, and furniture items are strictly prohibited. 4.

MoA on Rs. 100/- stamp paper in favour of Govt. of India and annexure I, II as per attached formats, date of sanction and sanction amount place should be 5. blank, after sanctioning of the project it should be filled. Each page should be signed and stamped by the project coordinator and Head of the Institute with the two witness sign at the last page.

Note that all purchases through DBT grant should be through Open Tender System and no specific brand/make should be given preference. An undertaking 6. need to be submitted for this, as per attached format.

Undertaking regarding data generated during the project i.e., if any valuable data arises, the same would be shared with IBDC at RCB. Faridabad, as per 7. attached format.

Kindly send PDF format of all documents (Must be duly signed & stamped by the Head of Institute / Principal & Programme coordinator at required place); complete above-mentioned formalities in a time-bound manner i.e. within 10 working days so as to ensure the consideration of the project.
